INDEPENDENT AUDITORS' REPORT

To the Board of Directors and Stockholder of

We have audited the accompanying consolidated financial statements of BCI Financial Group, Inc. and its subsidiaries (BCI), which comprise the consolidated balance sheets as of December 31, 2017 and 2016, and the related consolidated statements of income and comprehensive income, stockholder's equity, and cash flows for the years then ended, and the related notes to the consolidated financial statements.

Management's Responsibility for the Consolidated Financial Statements

Management is responsible for the preparation and fair presentation of these consolidated financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of consolidated financial statements that are free from material misstatement, whether due to fraud or error.

Accordingly, we express no such opinion. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluating the overall presentation of the consolidated financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the consolidated financial statements referred to above present fairly, in all material respects, the financial position of BCI as of December 31, 2017 and 2016, and the results of its operations and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

NOTES TO CONSOLIDATED FINANCIAL STATEMENTS AS OF AND FOR THE YEARS ENDED DECEMBER 31, 2017 AND 2016

1. ORGANIZATION AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

BCI Financial Group, Inc. (BCI), a wholly owned subsidiary of Banco de Credito e Inversiones, S.A. (the "Parent") and its subsidiary, City National Bank of Florida, Inc. and its subsidiaries (the "Bank"), is engaged in the general commercial banking business and provides a variety of related financial products and services through its branches in Miami-Dade, Broward, Palm Beach, and Orange Counties, Florida.

BCI also provides lease financing services through the Banks's wholly owned subsidiary, City National Capital Finance, Inc., with offices in Florida, Maryland, Illinois, Virginia, Texas, Pennsylvania, South Carolina, Connecticut, New York, North Carolina, and Oregon.

BCI and the Bank are subject to the regulations of certain federal agencies and undergo periodic examinations by those regulatory authorities.

During November 2017, the Bank entered into agreement to purchase TotalBank, subject to regulatory approval for approximately \$528,000,000.

The following summarizes more significant accounting and reporting policies of BCI:

Basis of Presentation—The accompanying consolidated financial statements of BCI have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP). The accompanying consolidated financial statements include the accounts of BCI and its subsidiaries in which BCI has a controlling interest. All intercompany balances and transactions have been eliminated in consolidation.

Use of Estimates—The preparation of consolidated financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the consolidated financial statements, and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and Cash Equivalents—Cash and cash equivalents include cash and due from banks with maturities of 90 days or less at purchase date and interest-bearing balances with financial institutions with maturities of 90 days or less at purchase date. Cash and cash equivalents at December 31, 2017 and 2016, were composed of the following amounts (in thousands):

Loans and Leases—Loans and leases are generally reported at the principal amount outstanding, net of unearned income, deferred loan fees and costs, and any direct principal charge-offs. Direct loan origination fees and costs are deferred, and the net amount is amortized over the estimated life of the related loans as a yield adjustment. Interest income is recognized based on the principal balance outstanding, computed using the effective interest method. Premiums and discounts on loans are amortized using a method, which approximates the level-yield method.

Loans acquired by BCI are recorded at fair value as of the acquisition date. Any allowance for loan and lease losses (ALLL) previously associated with these loans does not carry over to BCI and is eliminated.

Purchased loans are evaluated for credit deterioration at acquisition and recorded at their initial fair value. For loans acquired with no evidence of credit deterioration, the fair value discount or premium is amortized over the contractual life of the loan as an adjustment to yield. For loans acquired with evidence of credit deterioration (PCI), BCI determines at the acquisition date the excess of the loan's contractually required payments over all cash flows expected to be collected as an amount that should not be accreted into interest income (nonaccretable difference). The remaining amount representing the difference in the expected cash flows of acquired loans and the initial investment in the acquired loans is accreted into interest income over the remaining life of the loan or pool of loans (accretable yield). Subsequent to the acquisition date, increases in expected cash flows over those expected at the acquisition date are recognized prospectively as interest income over the remaining life of the loan. The present value of any decreases in expected cash flows resulting directly from a change in the contractual interest rate are recognized prospectively as a reduction of the accretable yield. The present value of any decreases in expected cash flows after the acquisition date as a result of credit deterioration is recognized by recording an ALLL or a direct charge-off. Subsequent to the purchase date, the methods utilized to estimate the required ALLL are similar to originated loans.

BCI's lease portfolio consists of both direct financing and leveraged leases. Direct financing leases are carried at the aggregate of lease payments plus estimated residual value of the leased property, less unearned income. Interest income on direct financing leases is recognized over the term of the lease to achieve a constant periodic rate of return on the outstanding investment.

Leveraged leases are carried at the aggregate of lease payments (less nonrecourse debt payments) plus estimated residual value of the leased property, less unearned income. Interest income on leveraged leases is recognized over the term of the lease to achieve a constant rate of return on the outstanding investment in the lease, net of the related deferred income tax liability, in the years in which the net investment is positive.

Nonaccrual Loans and Leases—Loans and leases are considered past due if the required principal and interest payments have not been received as of the date such payments were due. Loans and leases are placed on nonaccrual status when management believes the borrower may be unable to meet payment obligations as they become due or if the loan or lease becomes 90 days or more past due. Loans and leases may be placed on nonaccrual status regardless of whether or not such loans and leases are considered past due. When interest accrual is discontinued, all unpaid accrued interest is reversed. The accrual of interest is not discontinued on loans that are considered impaired due to modification and are performing under the modified terms. Interest payments received on loans and leases for which the accrual of interest has been discontinued are recorded as a reduction of the respective loan's principal balance. Interest income is subsequently recognized only to the

extent cash payments are received in excess of principal due. Loans and leases are returned to accrual status when all the principal and interest amounts contractually due are brought current and future payments are reasonably assured.

Loan or Lease Modifications—A restructuring of a loan or lease constitutes a troubled debt restructuring (TDR) if BCI, for economic or legal reasons related to the borrower's financial difficulties, grants a more than insignificant concession to the borrower that it would not otherwise consider. The loan or lease modifications that are considered a TDR by BCI pertain to restructuring the terms of the loan or lease to alleviate the burden of the borrower's near-term cash requirements, which include modifying the terms to reduce or defer cash payments required of the borrower in the near future, to help the borrower attempt to improve its financial condition and eventually be able to pay the loan or lease. The concession is granted by BCI as an attempt to protect BCI's investment on the loan or lease as much as possible. The primary concessions provided by BCI are a reduction of the stated interest rate for the remaining original life of the loan, extension of the maturity date or dates at a stated interest rate lower than the current market rate for a new loan or lease with similar risk, reduction of the face amount or maturity amount of the loan or lease as stated in the loan or lease agreement, and reduction of accrued interest.

Impaired Loans and Leases—Loans and leases are considered impaired when, based on current information and events, it is probable BCI will be unable to collect all amounts due in accordance with the original contractual terms of the loan and lease agreement, including scheduled principal and interest payments. If a loan or lease is impaired, a specific valuation allowance is allocated, if necessary, so that the loan and lease is reported net, at the present value of estimated future cash flows using the loan's and lease's existing rate or at the fair value of collateral if repayment is expected solely from the collateral. Impaired loans and leases, or portions thereof, are charged off when deemed uncollectible.

Allowance for Loan and Lease Losses—Provisions for loan and lease losses, which increase the ALLL, are established by charges to income. Such allowance represents the amounts, which, in management's judgment, are adequate to absorb losses on loans and leases, which may become uncollectible. The adequacy of the allowance is determined by management's continuing evaluation of the loan and leases portfolio in light of past loss experience, present economic conditions, and other factors considered relevant by management at the consolidated financial statement date. Anticipated changes in economic factors that may influence the level of the allowance are considered in the evaluation by management when the likelihood of the changes can be reasonably determined. In estimating the ALLL, consideration is given to asset performance, the financial condition of borrowers or guarantors, additional collateral provided, current and anticipated economic conditions, appraisals of collateral, and cost of disposal. While management uses the best information available to make such evaluations, future adjustments to the allowance may be necessary, which may be material, if economic conditions differ substantially from the assumptions used in the evaluation. If additions to the original estimate of the ALLL are deemed necessary, they will be reported in income in the period in which they become reasonably estimable.

Management believes that the ALLL is adequate; however, regulatory agencies, as an integral part of their examination process, periodically review BCI's ALLL. Such agencies may require BCI to recognize additions to the allowance based on their judgment and evaluation of information available to them at the time of their examination.

Management's continuing evaluation of its loan and lease portfolio includes the identification of commercial and business, real estate, and other loans and leases, which are considered impaired because it is probable that BCI will be unable to collect all amounts due according to the contractual terms of the loan or lease agreement. Individually identified impaired loans and leases are measured based on the present value of payments expected to be received, using the historical effective loan and lease rate as the discount rate. Alternatively, measurement may also be based on observable market prices or, for loans that are solely dependent on the collateral for repayment, measurement may be based on the fair value of the collateral. Loans that are to be foreclosed are measured based on the fair value of the collateral. If the recorded investment in the impaired loan exceeds the measure of fair value, a valuation adjustment is required as a component of the ALLL. Changes to the valuation allowance are recorded as a component of the provision for loan and lease losses.

During 2017 and 2016, BCI did not change its methodology pertaining to the ALLL estimate.

Trading Account Securities—Trading account securities are stated at fair value. Trading account securities are held in anticipation of short-term market movements. Gains or losses on the sale of trading account securities as well as unrealized fair value adjustments are included in other operating income. BCI did not hold any trading account securities as of December 31, 2017 and 2016.

Securities Available for Sale—Securities to be held for unspecified periods of time, including securities that management intends to use as part of its asset/liability strategy, or that may be sold in response to changes in interest rates, changes in prepayment risk, or other similar factors, are classified as available for sale and are carried at fair value. The appreciation or decline in value of these securities is reflected as a separate component of stockholder's equity and comprises the difference between net income and comprehensive income.

Securities Held to Maturity—Investments in debt securities to be held to maturity are carried at amortized cost as BCI has both the intent and ability to hold these securities to maturity.

Securities and Other Interest-Bearing Assets Income Recognition—Interest income is recognized over the term of the investment securities and other interest-bearing assets. Premiums and discounts on investment securities are amortized using a method, which approximates the level-yield method.

Derivative Financial Instruments—BCI uses interest rate derivative contracts, such as swaps, to manage exposure to changes in interest rates. BCI also uses interest rate swaps to facilitate certain commercial banking borrowers' risk management strategies related to the exposure to interest rate fluctuations. BCI does not enter into derivatives for speculative or trading purposes. BCI records all derivatives on the consolidated balance sheets at fair value.

BCI classifies its interest rate swaps derivative financial instruments as either (1) cash flow hedges derivatives that qualify for hedge accounting or (2) not designated as hedging derivatives.

Interest Rate Swaps Designated as Hedging Instruments—BCI utilizes these instruments to add stability to interest expense and to manage its exposure to interest rate changes. These interest rate swaps involve the receipt of variable interest rate amounts from a counterparty in exchange for fixed interest rate payments made by BCI. BCI assesses the effectiveness of these instruments at inception and at least quarterly over the life of the hedge by using regression analysis. Each instrument is expected to be highly effective in off-setting corresponding changes in the fair value or cash flows of the hedged item.

Changes in fair value of highly effective cash flow hedges are recognized in other comprehensive income until the related cash flows from the hedged items are recognized in earnings. If the hedge ceases to be highly effective, BCI discontinues hedge accounting and recognizes the interim changes in fair value in operating income. If a derivative that qualifies as a cash flow hedge is terminated or de-designated, the cumulative changes in value are recognized in income over the period in which the hedged item would have affected earnings. Immediate recognition in earnings is required if it is probable that the hedged cash flows will not occur.

Net interest derived from cash flow hedge instruments is reported in interest expense. Gains and losses resulting from the termination of swaps are recognized over the shorter of the remaining contract lives of the swaps or the lives of the related hedged positions, or, if the hedged positions are sold, are recognized in the current period as other income (expense).

Interest Rate Swaps Not Designated as Hedging Instruments—Derivatives not designated as hedges are not speculative and result from a service BCI provides to certain clients. BCI executes interest rate derivatives with commercial banking customers to facilitate their respective risk management strategies. Those interest rate derivatives are simultaneously hedged by offsetting derivatives that BCI executes with a third party, such that BCI minimizes its net risk exposure resulting from such transactions. As the interest rate derivatives associated with this program do not meet the strict hedge accounting requirements, changes in the fair value of both the customer derivatives and the offsetting derivatives are recognized directly in earnings.

Changes in the fair value of derivatives not designated as hedging instruments are recognized in operating income. Net interest received or paid on the interest rate swaps utilized to accommodate the financial needs of the customers is reflected as loan interest income.

Federal Home Loan Bank (FHLB) and Federal Reserve Bank Stock—FHLB and Federal Reserve Bank stock are carried at cost, as BCI's ownership is restricted and these stocks lack a market. Shares in these stocks can only be sold back at stated par and to the agency that issued them. BCI is required to maintain a specific level of holdings based on a formula provided by the respective agency.

Operating Leasing Equipment—Operating lease equipment is carried at cost less accumulated depreciation. Operating lease equipment is depreciated to its estimated residual value using the straight-line method over the lease term. Where management's intention is to sell the equipment received at the end of a lease, these are marked to the lower cost or fair value and classified as assets held for sale. Depreciation is stopped on these assets and any further marks to lower of cost or fair value are recorded in other income. Equipment received at the end of the lease is marked to the lower of cost or fair value with the adjustment recorded in other operating income. Maintenance costs incurred are expensed if they do not provide a future economic benefit and do not extend the life of the asset.

Bank Premises and Equipment—BCI premises and equipment are stated at cost, less accumulated depreciation and amortization. Depreciation is computed using the straight-line method over the estimated life of the assets, which is five years for computer equipment, seven years for furniture and office equipment and 39 years for buildings. Leasehold improvements are amortized over the lesser of their useful life or the term of the lease. Management reviews BCI premises and equipment for possible impairment whenever events or circumstances indicate that the carrying amount of an asset may not be recoverable. If there is an indication of impairment, management prepares an estimate of future cash flows (undiscounted and without interest charges) expected to result from the use of the asset and its eventual disposition. If these cash flows are less than the carrying amount of the asset, an impairment loss is recognized to write down the asset to its estimated fair value. Assets, if any, for which management has committed to a plan to dispose of the assets, whether by sale or abandonment, are reported at the lower of carrying amount or fair value, less cost to sell. Preparation of estimated expected future cash flows is inherently subjective and is based on management's best estimate of assumptions concerning future conditions. No impairment loss was recognized during the years ended December 31, 2017 and 2016, related to BCI premises and equipment.

Goodwill—Goodwill represents the excess of the purchase price over the estimated fair value of the net tangible and identifiable assets of businesses acquired.

BCI has elected the accounting alternative for the subsequent measurement of goodwill. Under the election, goodwill is amortized on a straight-line basis over 10 years. BCI evaluates the remaining useful lives of goodwill each reporting period to determine whether events and circumstances warrant a revision to the remaining period of amortization. Goodwill is also tested for potential impairment if an event occurs or circumstances change that indicate the fair value may be below its carrying amount (a triggering event). BCI did not record an impairment of goodwill during the years ended December 31, 2017 and 2016.

Intangible Assets—Intangible assets include the following: (1) core deposit premiums, (2) leasehold interest, and (3) trade name. The core deposit premiums and leasehold interest are amortized over their estimated useful lives. BCI evaluates the remaining useful lives of definite-life intangible assets in each reporting period to determine whether events and circumstances warrant a revision to the remaining period of amortization. Intangible assets are also tested for potential impairment whenever events or changes in circumstances suggest that an asset's or asset group's carrying value may not be recoverable. The trade name is not amortized, but tested annually for impairment. BCI has elected June 30 as the date of its annual impairment test. BCI did not record an impairment of intangible assets for the years ended December 31, 2017 and 2016.

Trust Department Assets—Securities and other property held by the trust department, in agency or other fiduciary capacities for customers, are not included in the accompanying consolidated financial statements.

Other Real Estate Owned—Foreclosed assets are carried at the lower of fair value, less estimated costs to sell, or cost. If the fair value of the asset, less the estimated costs to sell, is less than the cost of the asset, the deficiency is charged to income. BCI had approximately \$225,000 and \$467,000 of other real estate owned as of December 31, 2017 and 2016, respectively, all of which are classified as held for sale. BCI did not record impairment losses during the years ended December 31, 2017 and 2016.

Income Taxes—Deferred taxes are determined based on the estimated future tax effects of differences between the consolidated financial statements and tax basis of assets and liabilities given the provisions of enacted tax laws. Deferred income tax provisions and benefits are based on the changes in the deferred asset or liability from period to period. A valuation allowance is provided when it is more likely than not that some portion or all of the deferred tax assets will not be realized.

For positions taken or expected to be taken in a tax return, BCI recognizes the tax benefit in its consolidated financial statements when it is more likely than not (i.e., a likelihood of more than 50%) that the position would be sustained upon examination by tax authorities. A recognized tax position is then measured at the largest amount of benefit that is greater than 50% likely of being realized upon ultimate settlement.

Bank-Owned Life Insurance—BCI purchases life insurance policies on the lives of certain officers and employees and is the owner and beneficiary of the policies. BCI invests in these policies, known as BOLI, to provide an efficient form of funding for long-term retirement and other employee benefit costs. BCI records these BOLI policies at each policy's respective cash surrender value, with changes recorded in other operating income in the consolidated statements of income and comprehensive income (loss). Certain BOLI policies have a stable value agreement through a large, well-rated bank insurance carrier that provides minimum annual guaranteed increases in value, but passes on the full income and increase in value of the underlying pool of investments, less certain mortality and administrative expenses.

Off-Balance-Sheet Reserve for Credit Losses—Off-balance-sheet reserve for credit losses represents the amount which, in management's judgment, is adequate to absorb losses on commercial letters of credit, standby letters of credit, and commitments to extend credit, which may become uncollectible. The adequacy of the reserve is determined by management's continuing evaluation of BCI's commitments in light of past loss experience, present economic conditions, and other factors considered relevant by management at the consolidated financial statement date. Anticipated changes in economic factors that may influence the level of the reserve are considered in the evaluation by management when the likelihood of the changes can be reasonably determined. In estimating the reserve, consideration is given to asset performance, the financial condition of borrowers or guarantors, and current and anticipated economic conditions. While management uses the best information available to make such evaluations, future adjustments to the reserve may be necessary, which may be material, if economic conditions differ substantially from the assumptions used in the evaluation. If additions to the original estimate of the reserve are deemed necessary, they will be reported in income in the period in which they become reasonably estimable. As of December 31, 2017 and 2016, BCI's off-balance-sheet reserve for credit losses is \$1,365,000 and is recorded within other liabilities within the accompanying consolidated balance sheets. During the years ended December 31, 2017 and 2016, BCI did not record any change to the provision for off-balance-sheet credit losses.

New Accounting Pronouncements—During January 2016, the Financial Accounting Standards Board (FASB) issued guidance that amends the guidance on the classification and measurement of financial instruments. Although the guidance retains many current requirements, it significantly revises an entity's accounting related to (1) the classification and measurement of investments in equity securities and (2) the presentation of certain fair value changes for financial liabilities measured at fair value. The guidance also amends certain disclosure requirements associated with the fair value of financial instruments. The adoption of this guidance is effective for BCI for the year ending December 31, 2019. BCI is evaluating the effects that this guidance will have on its financial position, results of operations, and consolidated financial statement disclosure.

During February 2016, the FASB issued guidance that amends the guidance on lease accounting. The guidance introduces a lessee model that brings most leases on the balance sheet. The new guidance also aligns many of the underlying principles of the new lessor model with those of the FASB's new revenue recognition standard (e.g., those related to evaluating when profit can be recognized). Furthermore, the guidance addresses other concerns related to the current leases model. For example, the guidance eliminates the requirement for an entity to use bright-line tests in determining lease classification. The standard also requires lessors to increase the transparency of their exposure to changes in value of their residual assets and how they manage that exposure. The adoption of this guidance is effective for BCI for the year ending December 31, 2019. Early adoption is

permitted. BCI is evaluating the effects that this guidance will have on its financial position, results of operations, and consolidated financial statement disclosure.

During June 2016, the FASB issued guidance that amends the guidance on the impairment of financial instruments. The guidance adds an impairment model (known as the current expected credit loss (CECL) model) that is based on expected losses rather than incurred losses. Under the new guidance, an entity recognizes as an allowance its estimate of expected credit losses. The Accounting Standards Update is also intended to reduce the complexity of the guidance of impairment of financial instruments by decreasing the number of credit impairment models that entities use to account for debt instruments. The CECL model applies to most debt instruments (other than those measured at fair value), trade receivables, lease receivables, reinsurance receivables that result from insurance transactions, financial guarantee contracts, and loan commitments. However, securities available for sales are outside the model's scope. The adoption of this guidance is effective for BCI for the year ending December 31, 2021. Early adoption is permitted during the year ending December 31, 2019. BCI is evaluating the effects that this guidance will have on its financial position, results of operations, and consolidated financial statement disclosure.

During August 2016, the FASB issued guidance that amends the guidance on the classification of certain cash receipts and payments in the statement of cash flows. The primary purpose of the amendment is to reduce the diversity in practice that has resulted from the lack of consistent principles on this topic. The guidance added or clarified the following cash flow items: debt prepayment or debt extinguishment costs; settlement of zero-coupon debt instruments or other debt instruments with coupon interest rates that are insignificant in relation to the effective interest rate of the borrowing; contingent consideration payments made after a business combination; proceeds from the settlement of insurance claims; proceeds from the settlement of corporate-owned life insurance policies, including BOLI policies; distributions received from equity method investees; beneficial interests in securitization transactions; and separately identifiable cash flows and application of the predominance principle. The adoption of this guidance is effective for BCI for the year ending December 31, 2019. Early adoption is permitted. The guidance must be applied retrospectively to all periods presented, but may be applied prospectively from the earliest date practicable if retrospective application would be impracticable. BCI is evaluating the effects that this guidance will have on its consolidated cash flow statement presentation.

During March 2017, the FASB issued guidance on receivables-nonrefundable fees and other costs on purchased callable debt securities. This guidance shortens the amortization period for certain callable debt securities held at a premium. Specifically, the amendments to the guidance require the premium to be amortized to the earliest call date. The amendments do not require an accounting change for securities held at a discount; the discount continues to be accreted to maturity. This amended guidance is effective for BCI on January 1, 2019, with early adoption permitted. BCI is evaluating the effects that this guidance will have on its financial position, results of operations and consolidated financial statement disclosure.

During August 2017, the FASB issued guidance on the targeted improvements to the accounting for hedging activities, which is intended to better align risk management activities and financial reporting for hedging relationships. The new guidance eliminates the requirement to separately measure and report hedge ineffectiveness and generally requires the entire change in the fair value of a hedging instrument to be presented in the same income statement line as the hedged item. It also eases certain documentation and

assessment requirements. The guidance is effective for fiscal years beginning after December 15, 2019. Early adoption is permitted. BCI is evaluating the effects that this guidance will have on its financial position, results of operations and consolidated financial statement disclosure.

Subsequent Events—Events occurring subsequent to the date of the consolidated balance sheets have been evaluated for potential recognition or disclosure in the consolidated financial statements through January 30, 2018, the date the consolidated financial statements are available to be issued.

The contractual terms of the investments that were not other-than-temporarily impaired do not permit the issuer to settle the securities at a price less than the face value of the investment. Because BCI has the ability and intent to hold those investments until a recovery of fair value, which may be maturity and the creditworthiness of the issuers, the quality and amount of the underlying collateral, the lack of concentration in any geographical area, contractual obligations of the issuers, and rating histories, as well as the continued performance and amortization of certain of the securities, BCI does not consider the carrying value of those investments to be other-than-temporarily impaired at December 31, 2017 and 2016.

BCI periodically reviews residual values associated with its leasing portfolio. Declines in residual values that are deemed to be other than temporary are recognized as a loss. During 2017 and 2016, BCI did not recognize any residual value write-downs related to commercial leases. At December 31, 2017, the minimum future lease payments receivable for each of the years 2018 through 2022 were \$58,091,000, \$57,934,000, \$55,924,000, \$68,117,000, and \$30,442,000, respectively, and \$57,505,000 thereafter. During the years ended December 31, 2017 and 2016, BCI did not recognize any contingent rental income on direct financing commercial leases.

PCI Loans—BCI designates loans as PCI by evaluating both qualitative and quantitative factors. At the time of acquisition, BCI accounts for the PCI loans by individual analysis or by segregating each portfolio into loan pools with similar risk characteristics. Over the lives of the acquired PCI loans, BCI continues to estimate cash flows expected to be collected on each loan pool. BCI evaluates, at each consolidated balance sheet date, whether its estimate of the present value of the cash flows from the loan pools, determined using the effective interest rates, has decreased such that the present value of such cash flows is less than the recorded investment of the pool, and, if so, recognizes a provision for loan loss in its consolidated statements of income and comprehensive income, unless interest rate driven.

Additionally, if BCI has favorable changes in its estimates of cash flows expected to be collected for a loan pool such that the then-present value exceeds the recorded investment of that pool, BCI will first reverse any previously established allowance for loan losses for the pool. If such estimate exceeds the amount of any previously established allowance, BCI will accrete future interest income over the remaining life of the pool at a rate which, when used to discount the expected cash flows, results in the then-present value of such cash flows equaling the recorded investment of the pool at the time of the revised estimate.

The PCI loans are considered nonaccrual due to the fact that BCI cannot reasonably determine the timing and amount of cash flows expected to be collected. As of December 31, 2017 and 2016, the balance of nonaccrual PCI loans is \$10,517,000 and \$12,616,000, respectively. BCI does not have PCI loans, where BCI could reasonably estimate the timing and amount of future cash flows.

Risk Management—BCI has certain lending policies and procedures in place that are designed to maximize loan and lease income within an acceptable level of risk. Management reviews and approves these policies and procedures on a regular basis. A reporting system supplements the review process by providing management with frequent reports related to loan and lease production, loan and lease quality, concentrations of credit, loan and lease delinquencies, and nonperforming and potential problem loans and leases. Diversification in the loan and lease portfolio is a means of managing risk associated with fluctuations in economic conditions.

Real estate loans are subject to underwriting standards that are designed to promote relationship banking rather than transactional banking. Once it is determined that the borrower's management possesses sound ethics and solid business acumen, BCI's management examines the relevant information for a specific loan and presents it to the loan committee for approval. These loans are viewed primarily as loans secured by real estate. Real estate lending typically involves higher loan principal amounts and the repayment of these loans is generally largely dependent on the successful operation of the property securing the loan, the business conducted on the property securing the loan, or the borrower's personal ability to pay the loan. Real estate loans may be more adversely affected by conditions in the real estate markets or in the general economy. The properties securing BCI's real estate portfolio are of similar type and are concentrated in Florida; however, there are loans outside Florida. Management monitors and evaluates real estate loans based on collateral, geography, and the borrower's financial stability. Within real estate loans, BCI monitors the loan portfolio in the following subgroups: commercial, residential, and construction and land.

Commercial and other business loans are subject to underwriting standards and processes similar to real estate loans. Commercial and other business loans are primarily based on the identified cash flows of the borrower and secondarily on the underlying collateral provided by the borrower. The cash flows of borrowers, however, may not be as expected and the collateral securing these loans may fluctuate in value. Most commercial and other business loans are secured by the assets being financed or other business assets, such as accounts receivable, inventory, or real estate, and may incorporate a personal guarantee. In the case of loans secured by an operating asset, the availability of funds for the repayment of these loans may be substantially dependent on the ability of the borrower to collect amounts due from its customers.

BCI originates consumer loans utilizing credit-scoring analysis to supplement the underwriting process. To monitor and manage consumer loan risk, policies and procedures are developed and modified, as needed, jointly by line and staff personnel. This activity, coupled with relatively small loan amounts that are spread across many individual borrowers, minimizes risk.

Leasing transactions often involve onetime lending decisions of a more transactional nature than relationship nature and thus require strong credit quality. Lease repayments primarily rely on cash flow. Equipment or other collateral value is considered for secondary repayment and residual gain realization purposes. Leases are underwritten in accordance with BCI's goals of consistent high credit quality. Leases' credit risk is managed by assessing delinquency, special asset and substandard asset levels, and investment losses over time.

BCI engages independent loan reviewers that review and validate the credit risk profile on a periodic basis. Results of these reviews are presented to senior management and the audit committee. The loan review process complements and reinforces the risk identification and assessment decisions made by lending and credit personnel, as well as BCI's policies and procedures.

Concentrations of Credit—Most of BCI's lending activity occurs within the state of Florida. At December 31, 2017 and 2016, approximately 68% and 74%, respectively, of BCI's loans relate to real estate.

Credit Quality Indicators—As part of the ongoing monitoring of credit quality, BCI separates its loan portfolio into the following classifications:

- **Unclassified Loans**—Unclassified loans are loans that are performing and do not fall under any of the below categories.
- **Special Mention**—These are loans that are not individually analyzed; however, BCI has identified them for monitoring as they are considered marginally acceptable loans.
- **Substandard**—Loans aggregated into this subgroup include performing and nonperforming loans. For performing loans that are individually analyzed, BCI has determined several characteristics requiring increased scrutiny to establish that the loans are not impaired or require an additional reserve. The characteristics identified by BCI to be relevant to this subgroup are: (1) indication that the borrower(s) financial condition is deteriorating due to other debt maturing, the borrower's liquidity, weakness in the borrower's business, and other financial or borrower-specific indicators; (2) weakness in underlying collateral, such as land, condominiums, and commercial real estate; (3) if the borrower has other outstanding loans with BCI that are not performing or if BCI has a significant concentration of the borrower's debt; (4) if the loan is beginning to show signs of nonperformance (loans past due 30–60 days); (5) the loan to value has increased to a level that requires additional scrutiny; (6) the appraised value of the collateral is less than the loan balance; or (7) the loan is considered nonperforming.

- **Doubtful**—These are loans that are not performing, and BCI believes that the underlying collateral value or the source of repayment is not sufficient to recover the outstanding balance of the loan. These loans are considered impaired.

12. FAIR VALUE MEASUREMENTS

BCI values its financial assets and liabilities that are measured at fair value in accordance with a three-tier fair value hierarchy that prioritizes the observable and unobservable inputs used to measure fair value as follows:

Level 1—Quoted prices (unadjusted) for identical assets or liabilities in active markets as well as US Treasury securities that are highly liquid and are actively traded.

Level 2—Valuations for assets and liabilities traded in less active dealer or broker markets. For example, quoted prices for similar mortgage-backed securities in active markets and other observable inputs.

Level 3—Valuations for assets and liabilities not based on market exchange, dealer, or broker-traded transactions. Level 3 valuations are derived from other valuation methodologies, including discounted cash flow models and similar techniques, and incorporate certain assumptions and projections in determining the fair value assigned to such assets or liabilities.

As required by FASB guidance, when the inputs used to measure fair value fall within different levels of the hierarchy, the level within which the fair value measurement is categorized is based on the lowest-level input that is significant to the fair value measurement in its entirety; for example, a Level 3 fair value measurement may include inputs that are observable (Levels 1 and 2) and unobservable (Level 3). Therefore, gains and losses for such assets and liabilities categorized within the Level 3 table below may include changes in fair value that are attributable to both observable inputs (Levels 1 and 2) and unobservable inputs (Level 3).

A review of fair value hierarchy classifications is conducted at least on an annual basis. Changes in the observability of valuation inputs may result in a reclassification for certain financial assets or liabilities. The effective tax rate for 2017 and 2016 differs from the statutory Federal rate of 35% primarily as a result of tax reform adjustment, state income taxes and nondeductible expenses.

On December 22, 2017, the President of the United States of America signed into law the tax legislation H.R.1., commonly known as the Tax Cuts and Jobs Act (the "Act"). The Act reduces the corporate tax rate to 21%, effective January 1, 2018, for all corporations. Due to the Act, BCI revalued its deferred tax assets and liabilities existing as of the date of the

enactment, that are expected to reverse after January 1, 2018. The effect of this change is approximately \$41,571,000, which is included in income from operations as a component of income tax expense.

In assessing the realizability of deferred tax assets, management considers whether it is more likely than not, based on an evaluation of both positive and negative evidences as defined in FASB ASC 740, *Income Taxes*, that some portion or all of the deferred tax assets will not be realized. Although management believes that these deferred tax assets will ultimately be realized, it must recognize that such realization is dependent on the generation of future taxable income during the periods in which temporary differences are deductible. Under FASB ASC 740, management must consider the scheduled reversal of deferred tax assets, projected future taxable income, tax planning strategies, and whether BCI is in a three-year cumulative loss position in making this assessment. Management evaluated all available evidence, both positive and negative, and based on consideration of this evidence, which included earnings/loss history and anticipated future pretax income, as well as the reversal period for the items giving rise to the deferred tax assets and liabilities, management concluded that it was more likely than not that its net deferred tax assets would be realized at December 31, 2017 and 2016.

BCI's gross net operating losses of approximately \$120,471,000 of federal net operating losses and approximately \$76,064,000 of State of Florida net operating losses at December 31, 2017, will begin to expire during 2028.

BCI has approximately \$49,741,000 gross excess recognized built-in losses related to goodwill amortization, that are disallowed because of Internal Revenue Code section 382 limitation. These recognized built-in losses are carried forward and will begin to expire during 2036.

BCI accounts for uncertainty in income taxes by recognizing in its consolidated financial statements the tax effects of a position only if it is more likely than not to be sustained based solely on its technical merits; otherwise, no benefits of the position are to be recognized. Moreover, the more-likely-than-not threshold must continue to be met in each reporting period to support continued recognition of a benefit. As of December 31, 2017 and 2016, BCI has not recorded any unrecognized tax benefits in the accompanying consolidated balance sheets. Management does not expect that unrecognized tax benefits will increase within the next 12 months. In the event BCI was to recognize interest and penalties related to uncertain tax positions, they would be recognized in the consolidated financial statements as income tax expense.

Due to the 2015 acquisition of the BCI by Parent, BCI has been limited under the Internal Revenue Code Section 382 limitation to utilize approximately \$26,703,000 per year of its net operating losses and other tax attributes.

As of December 31, 2017 and 2016, BCI had a tax prepayment of approximately \$19,905,000 and \$398,000, respectively, which is included in other assets in the accompanying consolidated balance sheets.

Commercial letters of credit are instruments, whereby BCI substitutes its credit for that of its customers in connection with financing contracts for the shipment of goods from seller to buyer. BCI's acceptance of these instruments is contingent upon the presentation of the necessary documents to execute such contracts.

Standby letters of credit are conditional commitments issued by BCI to guarantee the performance of a customer to a third party. The credit risk involved in issuing letters of credit is essentially the same as that involved in extending loan facilities to customers. At December 31, 2017 and 2016, standby letters of credit amounting to approximately \$33,275,000 and \$22,823,000, respectively, were secured by cash collateral or marketable securities. The liability recorded by BCI related to unearned fees from letters of credit outstanding at December 31, 2017 and 2016, was \$231,000 and \$103,000, respectively, and is included in other liabilities in the accompanying consolidated balance sheets.

Commitments to extend credit are agreements to lend to a customer as long as there is no violation of any condition established in the contract. Commitments generally have fixed expiration dates or other termination clauses and may require payment of a fee. Since many of the commitments are expected to expire without being drawn upon, the total commitment amounts do not necessarily represent future cash requirements. BCI evaluates each customer's creditworthiness on a case-by-case basis. The amount of collateral obtained, if deemed necessary, is based on management's credit evaluation.

Litigation—BCI, from time to time, is a defendant in lawsuits that are incidental to its operations; the outcomes of these lawsuits have not had, and are not expected to have, a material effect on the results of operations or financial position of BCI.

15. EMPLOYEE BENEFIT PLAN

BCI has a Retirement Savings Trust and Retirement Savings Plan (the "Plan"), a defined contribution 401(k) plan. The Plan covers all employees who are 21 years of age with more than 90 days of service as of the Plan entry dates of January 1 and July 1. Employees qualify for benefits upon reaching the age of 65 years or upon permanent disability. Participants receive a 100% employer matching contribution up to 5% of their pretax compensation. In addition, BCI may make a discretionary contribution from current or accumulated profits. During the years ended December 31, 2017 and 2016, BCI contributed approximately \$2,111,000 and \$1,604,000, respectively, to the Plan in matching contributions.

16. REGULATORY MATTERS

BCI is subject to various regulatory capital requirements administered by the federal banking agencies. Failure to meet minimum capital requirements can initiate certain mandatory and possibly additional discretionary actions by regulators that, if undertaken, could have a direct material effect on BCI's consolidated financial statements. Under capital adequacy guidelines and the regulatory framework for prompt corrective action, BCI must meet specific capital guidelines that involve quantitative measures of BCI's assets, liabilities, and certain off-balance-sheet items as calculated under regulatory accounting

practices. BCI's capital amounts and classifications under the regulatory framework for prompt corrective action are also subject to qualitative judgments by the regulators about components, risk weightings, and other factors.

Quantitative measures established by regulation to ensure capital adequacy require BCI to maintain minimum amounts and ratios (set forth in the table below) of total and Tier I capital (as defined in the regulations) to risk-weighted assets (as defined) and of Tier I capital (as defined) to average assets (as defined). Management believes, as of December 31, 2017, that BCI meets all capital adequacy requirements to which it is subject.

As of December 31, 2017, BCI is categorized as well capitalized under the regulatory framework for prompt corrective action. To be categorized as well capitalized, BCI must maintain minimum total risk-based, Tier I risk-based, Common Equity Tier I (CET I), and Tier I leverage ratios as set forth in the table. There are no conditions or events since that notification that management believes have changed the institution's category.

The estimated fair value amounts have been determined using available market information and appropriate valuation methodologies. However, considerable judgment is required to interpret market data to develop the estimates of fair value. Accordingly, the estimates presented herein are not necessarily indicative of the amounts BCI could realize in a current market exchange. The use of different market assumptions and/or estimation methodologies may have a material effect on the estimated fair value amounts. Although management is not aware of any factors that would significantly affect the estimated fair value amounts, such amounts have not been comprehensively revalued for purposes of these consolidated financial statements since December 31, 2017, and therefore, current estimates of fair value may differ significantly from the amounts presented herein.

Cash and Cash Equivalents and Other Interest-Earning Assets—The carrying amount of cash and due from banks, interest-bearing deposits with financial institutions, and securities purchased under agreements to resell is a reasonable estimate of fair value due to the relatively short period to maturity of these instruments.

Securities—For securities, fair values are based on quoted market prices or dealer quotes. If a quoted market price is not available, fair value is estimated using quoted market prices for similar securities, or discounted cash flow models and similar techniques, and incorporates certain assumptions and projections in determining the fair value assigned to such securities.

FHLB and Federal Reserve Bank Stocks—The carrying amount of FHLB and Federal Reserve Bank stocks is a reasonable estimate of fair value as BCI's ownership is restricted and these stocks lack a market. Shares in these stocks can only be sold back at stated par and to the agency that issued them.

Loans and Leases—BCI has determined that the carrying value of variable-rate loans with good credit risk and variable-rate loans repricing in the near future approximates fair values. The fair value of other types of loans and leases are estimated by discounting the future cash flows using the current rates, at which similar loans and leases would be made to borrowers with similar credit ratings and for the same remaining maturities.

Accrued Interest Receivable—The carrying amount of accrued interest receivable is a reasonable estimate of fair value due to the relatively short period to maturity of these instruments.

Accrued Interest Payable—The carrying amount of accrued interest payable is a reasonable estimate of fair value due to the relatively short period to maturity of these instruments.

Demand Deposits and Time Deposits—The fair value of demand deposits, interest checking accounts, savings accounts, and certain money market deposits is the amount payable on demand at the reporting date. The fair value of fixed-maturity certificates of deposit is estimated using the rates currently offered for deposits of similar remaining maturities.

Other Borrowings—The fair value of other borrowings is estimated using the rates currently offered for borrowings of similar maturities.

Federal Funds Purchased and Securities Sold under Agreements to Repurchase—The carrying values for federal funds purchased and securities sold under agreements to repurchase approximate fair value due to the relatively short period to maturity of these instruments.

Derivatives—The fair values of derivative financial instruments are determined based on quoted market prices and internal pricing models that use market observable data. Interest rate swaps not designated as hedge derivatives carry a credit valuation adjustment that represents the consideration of credit risk (credit standing) of the counterparties to the transaction and the effect of any credit enhancements related to the transaction, as required by ASC 820. Interest rate derivatives designated as cash flow hedges fair value is determined by using regression analysis by valuing both the actual and the hypothetical derivatives under the forward curves from the last 37 calendar month-ends and calculating the difference in those values from the values calculated at the end of the previous month-end.

Off-Balance-Sheet Instruments—The fair values of commercial letters of credit, standby letters of credit, and commitments to extend are based on fees currently charged to enter into similar agreements, taking into account the remaining terms of the agreements and the counterparties' credit standing. Their fair values are not considered significant at December 31, 2017 and 2016.

18. RELATED-PARTY TRANSACTIONS

Loans—BCI makes loans to its directors, officers, employees, and other affiliated parties on substantially the same terms, including interest rate and collateral requirements, as those prevailing at the time of the loan origination for comparable transactions with nonaffiliated persons. The aggregate amount of direct loans to directors, executive officers, and principal stockholders at December 31, 2017 and 2016, amounted to \$1,657,000 and \$1,687,000, respectively. BCI did not have indirect loans to directors, executive officers, and principal stockholders at December 31, 2017 and 2016.

At December 31, 2017 and 2016, BCI has deposits from a related party in the amount of approximately \$2,723,000 and \$4,040,000, respectively.
